4. Medical certificate

I have been informed that a medical certificate by a pediatrician must be submitted (as per Clause 8), certifying that the health of my child/children allows them to participate in the sports and entertainment program of the ATTICA BOTANICAL PARK, about which the certifying physician will be fully informed by me. 5. Benefits

Children are provided with full meals, including breakfast, snack, and lunch, in collaboration with ATENE Catering (www.atenecatering.gr), accident insurance, as well as all materials required for activities.

6. Cost per period and discounts

It applies to periods 1 to 9

- **Cost for one child:**

210 Euros per period, for participation in one or two periods

190 Euros per period, for participation in three or more periods

- **Cost for siblings:**

190 Euros per period, for the second and each additional child, for participation in one or two periods

180 Euro per period, for the second and each additional child, for participation in three or more periods

It applies to the 10th period

- **Cost for one child:**

140 Euros for participation in the three-day 10th period.

- **Cost for siblings:**

130 Euros, for the second and each additional child, for participation in the three-day 10th period

It applies to all periods

- The additional cost for **morning and/or afternoon care** is 20 Euros per period
- In case of participation on **specific days** instead than the entire period, the cost per day is 50 Euros per child
- All above prices include VAT, accident insurance for each child, activity materials, as well as meals, regardless of whether the benefit will be used
- **15% early bird discount**, upon payment for the selected periods by May 20th, 2025

10. Cancellation policy

- In case of cancellation up to 15 days before the start of the first selected period, 100% of the amount paid will be refunded.
- In case of cancellation with notice up to 7 days before the start of the first selected period, 50% of the amount paid will be refunded.
- In case of cancellation with notice less than 7 days before the start of the first selected period, the amount paid will not be refunded.

12. Terms of participation

- 12.1 The Summer Camp of the ATTICA BOTANICAL PARK is addressed to children aged 5 to 12 years old. The submission of the Registration Form must be made no later than Tuesday afternoon of the week before the first selected period. Each child will participate in the period(s) selected through the Registration Form, upon availability. Any changes to the periods requested will be accepted only for serious reason and upon availability, following a request by the parent to the ATTICA BOTANICAL PARK secretariat.
- The child should wear comfortable clothes and sports shoes fully covering the feet. The child should also bring along a small backpack with: a hat, sunscreen, a water bottle, a change of clothes, and a use-only-garment for the workshops. For the activities in the pool, the child will need: swimming goggles, a swimming cap (optional), flip-flops, a swimsuit, a UV-protective swim shirt, and a towel. For all other activities, no additional equipment is required. The child's name must be written on the backpack, the water bottle, the hat, and the sunscreen. Children are not allowed to bring mobile phones, electronic devices, or valuables.
- Children must enter and exit the Summer Camp facilities at the designated times and always accompanied by a parent, in order to ensure the smooth operation of the Summer Camp's program. In case of any serious medical incident during the children's stay at the Summer Camp, the Camp Coordinator will immediately inform the parents using the contact numbers listed on the registration form.
- In the event that children do not comply with the staff's instructions and exhibit inappropriate behavior, the Summer Camp reserves the right to expel them from the camp

	without any refund. Moreover, it assumes no responsibility for any loss of personal items or valuables that the children bear.

13. Information and consent for the processing of personal data.

The ATTICA BOTANICAL PARK hereby informs you that it collects, processes, and stores the personal data listed on this Registration Form (child's name and surname, mother's name and surname, father's name and surname, child's date of birth, school grade completed, home address, place of residence, mother's mobile phone number, father's mobile phone number, home phone number, work phone number, other phone number, contact e-mail, child's health data, statistical data) regarding the activities program, and, upon case, any required payment details, in accordance with the provisions of the existing personal data legislation, namely Law 2472/1997, Law 4624/2019, and Regulation (EU) 2016/679 of the European Parliament and Council ("General Data Protection Regulation"), as in force (hereinafter "Personal Data Legislation"), and in accordance with the specific terms and conditions listed below:

THE ATTICA BOTANICAL PARK collects the above personal data from you exclusively for the purpose of ensuring the smooth operation of the Summer Camp, the fulfilling of the contract between us and the protection of the security and health of the children participating in it. The legal basis for the above processing is, on the one hand, your written consent granted herein, and on the other hand, the fact that the processing of the above personal data is necessary for the performance of the contract between us.

Regarding especially the parents' personal data contained in this document, the legal basis for the processing is, in addition to the written consent granted via the present by the one parent, to ensure the ATTICA BOTANICAL PARK's legitimate interest to communicate with the parents on matters concerning the child. Especially for the health data, the legal basis for the processing is, on the one hand, your written consent granted herein, and on the other hand, the fact that the processing is necessary for the purpose of providing medical assistance to the child, should it be required. The above personal data will not be transferred to any third party without your prior written consent. Furthermore, the ATTICA BOTANICAL PARK will not transfer the above personal data to any country outside the EU.

The above personal data will be made accessible and will be processed by authorized employees at the ATTICA BOTANICAL PARK, who will process them exclusively for the fulfillment of the above purposes and under no circumstances for personal interest. Furthermore, some of the above personal data will be made accessible and will be processed, within the scope of their responsibilities, by external collaborators, and specifically by an external accountant and a

cooperating insurance company (specifically, there will be provided: name and surname, father's name, and date of birth for the personal accident insurance contract. Personal health information for each participating child is explicitly excluded from the transfer), for the purpose of fulfilling our contract.

The ATTICA BOTANICAL PARK will retain and process the above personal data for as long as required to serve the aforementioned purposes of processing, as well as for as long as necessary to comply with its legal obligations and to defend itself against any legal claims. After the completion of the above-mentioned time period, it will proceed with the permanent deletion of the above personal data.

Subject to certain exceptions, terms, and limitations provided for in the Personal Data Legislation, you may exercise the right to access, correction, limitation of processing, objection, deletion of the above personal data, as well as the right to data portability. In the event of exercising any of the aforementioned rights, the ATTICA BOTANICAL PARK will take any feasible measure to fulfill your request in a timely manner, as specifically outlined and under the conditions of the Personal Data Legislation, informing you in writing on the fulfillment of your request, or on the reasons preventing you from exercising or fulfilling one or more of the aforementioned rights in accordance with the Personal Data Legislation.

In addition, you reserve the right to withdraw the present consent at any time, without this affecting the legality of the processing based on the present consent before its withdrawal. We inform you that, in the event of withdrawing your consent, we will not be eligible to use the above personal data, and the participation of your child in the Summer Camp will not be feasible. Furthermore, you have the right to file a complaint with the Personal Data Protection Authority if you consider that the processing of your personal data is not compliant with the applicable legislation.
